RECOMMENDATION: Approval to submit an application to the California Department of Education for the Carl Perkins VEA IIIC Vocational and Technical Education Grant. (Grant is written, implemented and monitored by ROP). Funds will be used for instructional supplies and equipment for vocational education classes in the high schools; upgrading Science and Math classes in the middle schools; salaries for bilingual instructional assistants, including three Special Needs instructional assistants; staff development; and Teen Mothers' Program support.
