Reena Singh, Senior Director, Regional Occupational Program. Career Technical Education (ROP/CTE), reported that during times of fiscal constraints and diminishing revenue limits grants become the engine that drives change, excellence and becomes the fiscal backbone to continue excellence in education; stated that the Carl D. Perkins Career and Technical Education Improvement Grant, in the amount of \$2.7 Billion, supports the entire country for career technical education; that the District's allocation was \$400,000; that the funds would enable ROP/CTE to continue to upgrade the technology in the classrooms; reported on the ROP Advisory Board Meeting and information pertinent to Categorical Program Monitoring (CPM), a coordinated review and findings from the State; and shared data from the Student Career and Higher Education Plan.
