California Association of Regional Occupational Centers and Programs (CAROCP) Legislative Priorities - March Legislative Forum 2011.

**Reena Singh, Senior Director, Regional Occupational Program. Career Technical Education (ROP/CTE),** commented on the (CAROCP) Legislative Priorities – March Legislative Forum 2011; commented on the budget cuts to education; reported that 2 ½ years ago ROP/CTE became a part of the Flexibility Tier III programs; explained that the ROP funds have been swept into General Funds; that the ROP program was now facing a budget deficit (initially had a reserve of \$4.3 million); requested that the District support the Governor’s proposal to extend the temporary taxes; support Senate Bill 275 proposed by Senator Lori Hancock for a new State Accountability System for ROP/CTE; and addressed questions and concerns raised by the Board.
