





## **Public Content**

### **BACKGROUND:**

One of the NPAs (non public agencies) that we contract with provides Applied Behavior Analysis (ABA) to some of our. Students with autism is the fastest growing disability in the nation, and CUSD currently has approximately 300 students identified with the disability.

Of this 300, there are 14 students receiving ABA services, per their IEP provided by Autism Spectrum Therapies, Inc. ABA services provide intervention and support on modifying the challenging behaviors that are often associated with Autism. Most of the students are Pre-K through 5<sup>th</sup> grades. Early intervention may reduce the amount of service required as students increase in age.

We've recently received more students with Autism into the district whose IEPs list ABA services. As a result of this increase, it is necessary to amend the original budget for this agency. The increase will also supply a cushion through the remainder of the school year in the event of additional students.

### **IMPLICATIONS:**

**Due to an increase of students** moving into the district with Autism requiring services from a Non Public Agency (NPA) and in order to remain compliant, it is therefore necessary to increase the 2011-12 budget projection from its original submission. The increases would be as follows:


