Assembly Bill 1330 (authored by California State Assembly Member Warren Furutani), Career Technical Education Course Option for Graduation.

Reena Singh, Senior Director, Regional Occupational Program. Career Technical Education (ROP/CTE), welcomed the newly elected Board Member, Skyy Fisher, and re-elected members Mr. Ali and Mrs. Sharif; provided information about AB 1330 and explained that it would allow career technical education courses to count toward meeting the state mandated graduation requirement as an option to foreign language or the visual and performing arts; stated that the bill would be effective beginning with the 2012-2013 school year. Mrs. Singh reported that the ROP Budget was in a deficit mode and appealed to the Board to consider including the Academy Model as the District receives grants; and explained that the Career Technical Education must continue to advance in order for students to remain competitive in the job market.
